Swimming parties are SEMI-Private and must be scheduled two weeks in advance. The fees include the use of the pool and a designated area for refreshments for a total of two hours. Toys are permitted with the exception of inflatables such as rafts or mermaid tails. All children ages 8 and under are required to have an adult with them in the pool. The pool ranges from 3-12 feet and has a diving board. Participants under the age of 18 must pass a swim test administered by the lifeguard in order to swim in the deep end. The aquatics director will contact you to confirm your specified date

## **Pool Parties:**

- If the commons area was not reserved for your party, food/drinks will NOT be allowed.
- Reservations must be made at least 2 weeks in advance. Pool parties must be paid for at the time of reservation, in order for your date to be saved.
- Everyone that comes to the pool party must sign the liability waiver at the front desk upon entering the building.
- All pool parties are 2 hours. A total of 2 hours in the designated party area and the pool or 2 full hours in the pool You will have 15 minutes after the party concludes to vacate the facility.
- The 2 hour reservation time INCLUDES 30 minutes before to set up and 30 minutes after to clean up. Participants are not allowed into the pool prior to the start time of the party.
- The party should provide their own decorations, refreshments, etc. and are responsible for all clean up of these items.
- Cameras are not permitted in the locker rooms.
- The Twin Pike Family YMCA is not responsible for broken, lost or stolen items.
- All children 8 and under must be supervised by an adult or sibling over 16 years of age.
- A swim test will be administered to any child under 18 or to any person the lifeguard may be concerned about in regards to their swimming ability.
- Bathing suits are required for all swimmers. Any swimmer 3 years and under must wear a swim diaper in the pool at all times.
- Smoking and alcoholic beverages are not permitted inside the YMCA or on the YMCA grounds or at facilities managed by the YMCA.
- Cancellation of the party in writing with fewer than 3 days notice or a "no show" on the date of the party will result in a full loss of fees paid.
- If there are unforeseen circumstances that cause the pool to be closed, we will offer you an alternative date.
- Any organization booking a party will need to provide a certificate of insurance.

All participants must follow all posted pool and facility rules.
